2. Performance is Contingent upon Release. Performer understands that any and all performance at Impact Field is contingent upon Performer's grant of this Release. Performer shall not perform without such release being in full force and effect. This release cannot be withdrawn in whole or in part, and shall remain in full force at any time Performer attends Impact Field as a Performer, for the entire period of such attendance, whether or not performing.
3. Photo License. Performer grants The Dogs perpetual license, without compensation, for any and all use or publication of Performer name(s), information and likenesses, in whole or in part, whether still, motion or otherwise, in any medium or forum, whether known or later created, for any purpose whatsoever, including, but not limited to, marketing, advertising and/or promotion, to fullest extent of the law.
4. Waiver and Release. Performer, including all persons in Performer's group, whether or not performing, hereby releases, waives, indemnifies and holds The Dogs harmless against any and all lawsuits, claims or causes of action for any partial, temporary, permanent or complete damage or loss, whether the result of negligence, gross negligence or intentional acts, as well as for any and all liability whatsoever, whether personal injury (including death), property loss or other damage, to themselves or others, that relates in any manner whatsoever to Performer's attendance at Impact Field for any performance by Performer, or in any promotions or any other matters whatsoever.
